

**2017 Brown County Fair
Rules & Expectations for Exhibitors Staying Overnight at the Fairgrounds**

Youth exhibitors who want to stay at the fairgrounds overnight during the Brown County Fair must complete and return the permission slip below to the Brown County Fair Association by August 16, 2017.

The Brown County Fair Association will provide 24-hour security for the fairgrounds during the week of the Fair. Buildings will close at 10:30 pm each evening and will be regularly monitored by security officials.

Any actions and/or behaviors of a Fair exhibitor who is camping on the grounds that is deemed inappropriate by the chaperone(s), superintendent(s), Brown County Fair Board members and/or security personnel may result in disciplinary action up to and including immediate removal from the fairgrounds. Specific infractions that can result in discipline or dismissal from the fairgrounds include but are not limited to the following:

Adult chaperones (21 years of age and older) are expected to stay on the fairgrounds from 11:30 pm to dawn. The ratio is one adult to 10 youth. NO ALCOHOL may be consumed by adult chaperones while on duty.
