We are excited to hear you/your student has expressed interest in participating in the Brown County Fair Livestock & Dairy Auction at this year's Brown County Fair. The Livestock & Dairy Auction Committee hopes to provide assurance and guidance as you/your student chooses to embark on this unique and special learning opportunity.

Commitment to raising an auction animal at county fair is a remarkable experience that many professionals and industry leaders value. As anything with value, qualifying for auction requires a large amount of dedication, hard work and support.

Students interested in participating in the Brown County Fair Animal Auction must meet a list of requirements developed by the Brown County Fair Livestock & Dairy Auction Committee. Requirements and directions needed to be auction eligible are located in the Auction Portal, located on the Brown County Fair Website Exhibitor Page and in this informational booklet.

The Auction Portal serves as the informational hub for auction qualification status. The Student/Parent can log in to the portal to view the checklist of requirements, instructions on completing the requirements, submit requirements, and view the requirement status. Students must complete and meet approval for 100% of the items on the checklist to be auction eligible. Students must also meet species specific requirements listed in this informational booklet.

Knowing that this experience can be new/overwhelming/intimidating for many, we are here to help your student along this journey. In order to help the initial planning process, we have created this helpful booklet. Upon reading the booklet, we hope that you see the educational value in which you/your student have/has found interest.

This booklet should help answer some of the most popular questions about qualifying for the Brown County Fair Animal Auction. If your question is not in this manual, we encourage you to ask questions!

***Each student/parent must register to see requirements**

REGISTER FOR AN ACCOUNT

New Participant:

Register for an account by choosing the register button at the bottom of the prompt.

Previous Participant:

If you have previously registered, you can log in with registered username and password.

CHOOSE STUDENT OR PARENT

New Participant:

When registering for an account, you will be prompted for the type of account you are creating. You can choose parent or student account.

Student Accounts:

If signing up for student account, student is responsible for requirements, parent will not receive notification emails.

*You cannot register for a student account if you are younger than 13 years of age.

Parent Accounts:

A parent can create one account for all children. Parent will receive notifications via email registered. Once child turns 13 years old, parent can approve and transfer child to student account if they choose, when they choose.



CHOOSING YOUR SPECIES

When choosing your species, you must select the animals in which you are interested in selling at the auction. You CAN select more than one species, however, only animal can be sold.

If selecting more than one species, you will be expected to submit requirements for all species selected in order for the committee to mark specific requirements approved.


School Grade as of Jan. 1*





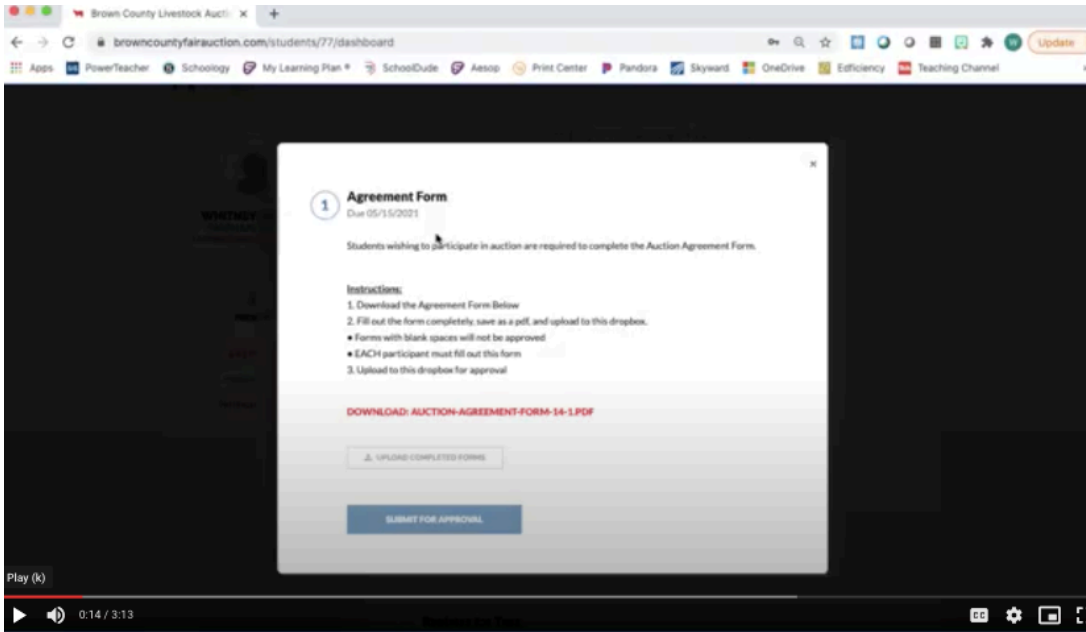
PLEASE NOTE

- STUDENTS/FAMILIES ARE RESPONSIBLE FOR MEETING ALL REQUIREMENTS BY THE DEADLINE
- FAILURE TO MEET THE DEADLINES ON THE PORTAL MAKES A STUDENT INELIGIBLE FOR AUCTION
- SUBMISSIONS MUST BE MARKED AS **APPROVED** TO BE ELIGIBLE
- EMAIL NOTIFICATIONS ARE SENT WHEN SUBMITTED ITEM IS NOT APPROVED WITH SUGGESTION
- IF THE REQUIREMENT STATUS IS PENDING BY MIDNIGHT OF THE DEADLINE DATE AND IS DENIED AFTER THE DEADLINE, THE STUDENT HAS THE OPPORTUNITY TO SUBMIT ONE MORE SUBMISSION WITHIN 1 WEEK OF NOTIFICATION. IF STUDENT FAILS TO RESPOND, STUDENT IS MARKED AS INELIGIBLE.

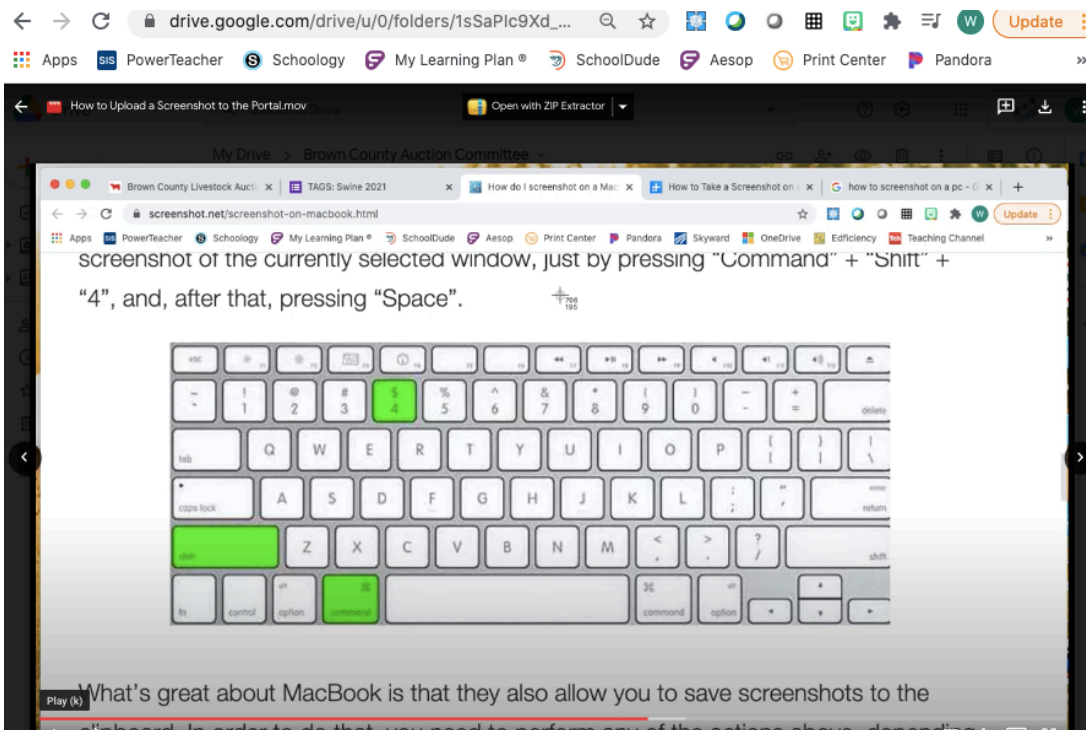

FREQUENTLY ASKED QUESTIONS

CAN I SHOW MORE THAN ONE ANIMAL IN THE AUCTION?

A student can show multiple auction eligible animals, but after the fair show is complete, only 1 animal/basket per exhibitor is allowed in the auction. Students are able to select the animal upon completion of the show on the consignment form in the auction portal.

I HAVE 2 ANIMALS THAT WOULD BE GREAT FOR AUCTION. WHEN DO I HAVE TO DECIDE WHICH ANIMAL I WANT TO SELL AT THE AUCTION?

Students can sell only one animal in the auction. Students can decide the specific animal after the completion of the species show. All students wishing to participate in auction must fill out a Consignment Form. The Consignment form signifies which animal the exhibitor would like to sell in the auction.

ARE THERE OTHER REQUIREMENTS BESIDES THE CHECKLIST?

Explain ribbon requirement with species- (pigs)

WHAT % PROFIT EARNED BY THE COMMITTEE FROM THE AUCTION?

*-13% Dairy Basket above market price
-8% Livestock Species above market price
-2% of gross sales Brown County Fair above market price
0% for State Fair Trucking
0% Scholarship Fund*

WHAT DO I WEAR ON AUCTION DAY?

We suggest students dress to impress in SMART CASUAL (No holes in jeans, no screen printed shirts, etc). Show clothes are appropriate. Students representing dairy do not need to wear whites.

WHAT CAN I BRING INTO THE AUCTION RING WITH MY ANIMAL?

We suggest blue ribbons or higher, show or showmanship trophies/awards earned during the current fair year.

HOW DO I RECRUIT BIDDERS TO INCREASE MY SALE PRICE?

Think about your personal network - who do you know that could be a potential bidder? Someone your parents work with, someone from your church, etc..

-personal meeting/drop off

-letters to leave after the personal meeting or send in mail

Spend time with bidders during the luncheon / meet and greet.

-Sell yourself, explain the work you've done, things you've learned along the way and what your plans the future are.

Dress Nice and Smile in the ring.

Thank your contacts for attending the auction with a handshake

Thank bidders personally after purchasing your animal

WHERE ARE THE ANIMALS SOLD IN THE AUCTION PROCESSED?

Beef/Swine/Sheep/Meat Goat: Roskom Meats

Rabbits/Poultry-Students are responsible for delivering animal processed

Dairy Cow/Goat: Animals Return Home

Resale: Equity

IS THERE A PLACE THAT I CAN TAKE MY POULTRY TO BE PROCESSED?

Many students the sell poultry in the auction choose to process their own poultry, but a few choose to have their animal processed by Small Beginnings Poultry in Gillett, WI. If the student chooses to not process the animal themselves, the student must make their own arrangements to have the animal processed.

WHAT IS THE MINIMUM/MAXIMUM AGE TO BE AUCTION ELIGIBLE?

Minimum: Age 9 by January 1st of current fair year (summer after 3rd grade)

Maximum: Under 20 years of age on January 1st of current fair year

I SHOW DAIRY CATTLE/DAIRY GOATS, HOW CAN I STILL PARTICIPATE IN AUCTION?

When exhibiting a Dairy animal (Goat, Heifer or Cow), a Dairy Basket is sold in place of the animal and the participant keeps their animal. Baskets are compiled and provided by the committee at a value of \$75-\$100.

Any student exhibiting Dairy that earns 1st Blue in Class, 1st in Showmanship, 1st place for Dairy Proficiency are auction eligible if they have completed the list of auction requirements in the portal.

CAN I SEND ALL MY ANIMALS TO BE PROCESSED AT THE END OF FAIR?

Only animals sold in the auction will be sent to our partnering processor(s). Animals not sold in auction will be sent home with the exhibitor. Exhibitors are responsible for scheduling processing with a processing facility for their livestock that is not sold in the auction.

HOW DOES RESALE WORK?

Several of our generous supporters who purchase animals at the auction sale choose not to have them all processed for their freezer. The purchaser will, when they pay the cashier for the animal(s) purchased, fill out a form to either process the animal at our partnering processor(s) OR they can choose to send their animal for resale at either an Equity livestock market or American Foods Group where the animal will be resold at auction/market price and the purchaser will receive a check from the resale market
