### EXHIBIT ENTRY/PROCESSING FEE (Paper copy, not on the computer)

Each exhibitor is required to pay a \$8.00 processing fee to be submitted with their entry form. **No refunds.**

### EXHIBITOR DAILY TICKET

Exhibitors are able to purchase a \$12 daily ticket, which will be exchanged for the wristband of the day. This ticket will get you into the fair, entitle you to unlimited carnival rides, and all entertainment at the fair for one day. **This ticket is only available to be purchased until July 15.**

### EXHIBITOR WRISTBAND

Exhibitors are able to purchase a \$15 wristband for youth and \$20 wristband for adults. **The wristband will be put on by the fair office and must be worn at all times. The wristband must be obtained prior to the opening of the Fair.** This wristband will get you into the fair daily but **does not include rides.** **This pass is only available to be purchased with entry forms.** This is not required, daily passes can be purchased instead, you do not need both. You can purchase a weekly wristband that includes rides for \$55.
